### **Park Rules and Regulations**

1. Alcoholic beverages prohibited
2. Using any facility for other than its intended purpose is prohibited
3. Loud and boisterous conduct is prohibited
4. Amplified sound equipment is prohibited except by permit
5. All pets must be on a leash
6. Motor vehicles are prohibited except on designated roads and parking areas.
7. Speed limit 15 miles per hour
8. Littering or dumping prohibited
9. No overnight parking without authorization
10. Tents, inflatables, motorized vehicles, and grilling are not allowed in any of the parks.

### **Decorations**

Decorations must be free-standing or tie-on. The use of tape, glue, tacks, staples, Command Strips or any similar product on any part of the pavilion is strictly prohibited. Artificial flower petals, confetti and silly string are not allowed.

### **Cancellations**

Cancellations must be made using the Request for Refund Form at least 30 days prior to the event date, in which case payment will be refunded minus an administrative fee of 20% of total rental cost. Any cancellation made within 30 days of the event date will result in 100% forfeiture of total cost.

In case of inclement weather, you may reschedule the event for another available date and/or facility of equal or lesser value. Requests for a future date must be made within 5 business days. Refunds will not be given in the event of inclement weather.

### **Date Changes**

A penalty fee of 20% of total rental cost will be applied when the rental date is changed 30 days prior to the date of rental. A rental date change within a 30 day period of the event date will result in 100% forfeiture of total cost. A new reservation must be scheduled to secure use of the facility.
